- Step 1: Determine Eligibility:** Equipment must be new and installed in a facility which is a Four Flags Energy Savers electric customer.
- Step 2: Install Equipment.** New equipment must be installed and old equipment removed. Only new products which are exact product types listed in this form are eligible for prescriptive incentives. Please call 877-674-5295 for approval before installation.
- Step 3: Complete and sign the application.** Incomplete applications will cause delays in payment. Forms *must* be received within 30 days of installation.
- Step 4: Include the following documentation with your incentive application:**
- Itemized invoices including costs for equipment installed and installation labor.

Terms and Conditions

1. **Incentive Offer:** Projects must be implemented (completed) by December 31, 2009. An original signed application and invoices for materials and labor must be delivered via mail to Four Flags Energy SaversSM 1219 Turner Street, Lansing, MI 48906 or faxed to 1-517-316-9027 **within 30 calendar days of installation (completion)**. Please keep a copy for your records.
2. **Proof of Purchase:** This application must have complete information and be submitted with 1) an invoice itemizing the **new equipment purchased and 2) the manufacturer (OEM) specification sheets**. The invoice must indicate date of purchase, size, type, make, model and total project cost.
3. **Energy Savings:** Projects must result in reduced electric energy use due to improvement in the system efficiency; control upgrades may also qualify. Reduced electric use resulting from peak shaving, demand limiting, fuel switching, power generation, renewable energy, or operating schedule changes does not qualify. To qualify lighting must be used a minimum of 1,800 hours per year.
4. **Compliance:**
 - a. All projects must comply with applicable federal, state, and local laws.
 - b. All equipment must be new or retrofitted with new components per the program specifications. Used or rebuilt equipment is not eligible for incentives. Existing equipment must be removed or permanently disconnected.
 - c. Equipment must meet specification requirements and be purchased and operating prior to submitting an incentive application.
 - d. Only one incentive will be granted for each project.
 - e. All projects must be a retrofit / replacement installation in an existing building (not available for new construction).
 - f. If the project is in a leased building, the term of the lease must be at least five (5) years.
5. **Payment:** Once completed paperwork is submitted, incentive payments are usually made within **30** calendar days. Incomplete applications will either delay payments or result in denial of application approval. The Four Flags Energy Savers program reserves the right to refuse payment and participation if the customer or contractor violates program terms and conditions. All projects exceeding **\$5,000** of incentives will be inspected prior to incentive payment. The Four Flags Energy Savers program must receive 100% of the energy savings for the rated life of the product(s) or for a period of three (3) years from receipt of rebate, whichever is less. If you do not provide the energy savings, if the facility in which the installed projects are located closes or ceases operation within the three (3) years from receipt of rebate or if you cease to be a customer of the Four Flags Energy Savers during the three (3) years, you shall refund a prorated amount of rebate dollars based on the time installed.
6. **Inspection:** Program staff may conduct an inspection of the facility to survey installed projects.
7. **Publicity:** The Four Flags Energy Savers program reserves the right to publicize your participation in this program, unless you specifically request otherwise.
8. **Program Discretion:** Incentives are available on a first-come, first-served basis. Incentive amounts and offerings are subject to change or termination without notice at the discretion of The Four Flags Energy Savers program.
9. **Logo Use:** Customers or allies may not use The City of Four Flags nor the Four Flags Energy SaversSM name or logo in any marketing, advertising, or promotional material without written permission.
10. **Disclaimers:** The Four Flags Energy Savers:

INCENTIVE LIMIT:

Purchase and install qualifying equipment and receive an energy efficiency incentive of up to **\$7,500** per project. All projects must receive written approval BEFORE project installation. Incentives may **not exceed 50% of the total project cost, including materials and labor**.
